feet, and would result in a total floor area of 2,288 square feet, which is less than the maximum floor area permitted for a lot of this size.

The exterior façade of the residence would not be altered. The new exterior areas would match the existing painted colors, trim, and asphalt shingles of the existing residence.

It should be noted that the subject property is located in the flood zone. The Building Division requires that all new construction in the flood zone be at least one foot above the base flood elevation. The current plans do not explicitly reflect this requirement; however, Staff does not anticipate any view or privacy impacts resulting from altering the foundation to meet the said standard.

ANALYSIS

Design Issues

The subject house is situated along Cecilia Way and backs up to properties above on Leland Way and Claire Way. There is existing wood fencing along the side and rear property lines that will decrease the visibility of the proposed project from adjacent neighbors.

The width of the existing structure would not change and a small portion of the addition would be located at the front of the house. The proposed addition would have a gabled roofline which would increase the maximum height of the structure to 16 feet, 2 inches.

The proposed rear elevation would contain four sets of glass doors. The living room doors would have clerestory windows above. The master bedroom addition would extend into the rear yard creating an L-shaped structure where doors would open into the center of the yard. The right side of the structure would not have any new windows. The rear elevation of the proposed master bedroom would contain doors opening onto a new 117 square foot deck. An additional L-shaped 272 square foot deck would be added beyond the kitchen, great room, and master bedroom.

The proposed addition does not appear to have a view or privacy impact on surrounding properties. Staff does not foresee any other design issues with this project.

Zoning

Staff has reviewed the proposal and finds it to be in conformance with the development standards for the R-1-B-A zone.

Public Comment

To date, no public comment has been received regarding this project.

CONDITIONS OF APPROVAL

294 CECILIA WAY

1. This approval shall be used within three (3) years of the approval date, and shall become null and void unless a building permit has been issued.
2. The development of this project shall conform with the application dated by the Town of Tiburon on March 20, 2006, or as amended by these conditions of approval. Any modifications to the plans of March 20, 2006, must be reviewed and approved by the Design Review Board.
3. Plans submitted to the Building Division for plan check shall be identical to those approved by the Design Review Board. If any changes are made to the approved Design Review plans, the permit holder is responsible for clearly identifying all such changes when submitted to the Building Division for plan check. Such changes must be clearly highlighted (with a "bubble" or "cloud") on the submitted plans. A list describing in detail all such changes shall be submitted and attached to the building plans, with a signature block to be signed by the Planning Division Staff member indicating that these changes have been reviewed and are approved, or require additional Design Review. All changes that have not been explicitly approved by Staff as part of the Building Plan Check process are not approved. Construction that does not have Planning Division approval is not valid and shall be subject to stop work orders and may require removal.
4. The applicant must meet all requirements of other agencies prior to the issuance of a building permit for this project.
5. All exterior lighting fixtures must be shielded, down light type fixtures.
6. No lighting shall be installed in the wells of the skylights, and the skylights shall be tinted in a non-reflective manner.
7. A survey shall be submitted along with the building permit showing that new construction shall be located at least one foot above base flood elevation.
8. If this approval is challenged by a third party, the property owner/applicant will be responsible for defending against this challenge. The property owner/applicant agrees to defend, indemnify and hold the Town of Tiburon harmless from any costs, claims or liabilities arising from the approval, including, without limitations, any award of attorney's fees that might result from the third party challenge.
